AS A COMMON CARRIER OF SPECIAL COMMODITIES
OVER IRREGULAR ROUTES

A CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY IS HEREBY GRANTED TO **GATOR ENVIRONMENTAL SERVICES, LLC DBA QUALA INDUSTRIAL SERVICES, LLC**¹ whose office or place of business is at **TAMPA, FLORIDA** authorizing operations in Louisiana intrastate commerce as a COMMON CARRIER OF **WASTE OVER IRREGULAR ROUTES** by motor vehicle.

Transportation of waste by motor vehicle, statewide.

Restricted against the transportation by dump trucks of regulated non-hazardous solid waste originating in the parishes of St. John the Baptist, St. Charles, and St. James. This restriction is applicable only to the transportation of non-hazardous solid waste in dump trucks.

Restricted to transportation of hazardous and non-hazardous solid waste and sludge in no more than a total of five tractor-trailer units consisting of two (2) bobtail roll-on roll-off box units and three (3) tractor roll-on roll-off trailers. (Clarification was provided at the hearing and subsequently through filings that the intent of this restrictive amendment is to provide a limitation on the type and quantity of equipment to be used in transporting nonhazardous solid waste and sludge only. There is no intent to restrict transportation of liquid waste.)

Restricted against transportation of hazardous or non-hazardous solid waste or sludge by lease-operators or owner-operators.

Applicant agrees that no application for additional or expanded authority for the transportation of waste intrastate in the State of Louisiana shall be filed for a period of four (4) years from the date of issuance of this common carrier certificate.

(Reissued pursuant to Order S-36588 to add a dba for a name change to Gator Environmental Services, LLC Quala Industrial Services, LLC previously issued in Order S-33997 transferred from Qualawash Holdings, LLC and originally issued pursuant to Order No. T-33736 for a sale and transfer from GATOR ENVIRONMENTAL & RENTALS, INC. originally issued pursuant to T-33461 dated August 13, 2015. Except for cause beyond control, non-operation of an authority for a period of six (6) months could lead to its cancellation pursuant to La. R.S. 45:166, Paragraphs B and C.)

Said **GATOR ENVIRONMENTAL SERVICES, LLC DBA QUALA INDUSTRIAL SERVICES, LLC** shall perform such operations under tariffs now or hereafter filed with the Commission and in compliance with all laws and rules and regulations of the Commission bearing thereon.
