**ORDER OF DISMISSAL**

The Louisiana Public Service Commission (“Commission”) issued a citation to Carnival Wrecker Service, LLC (“Carrier”) on July 10, 2025, directing the Carrier to appear at a hearing on September 4, 2025. Notice of the proceeding was published in the Commission’s *Official Bulletin* on July 18, 2025. On July 25, 2025, the Commission Staff filed a *Motion to Dismiss* advising that all issues have been resolved and requesting that the proceeding be dismissed with prejudice.

This dismissal is prepared in accordance with Rule 56(d) of the Rules of Practice and Procedure of the Commission, which provides:

Except at the discretion of the administrative law judge, the procedures contained within subpart (a) of this Rule shall not apply to a motion to dismiss jointly filed by all parties of record, a motion to dismiss with prejudice filed by the party who instituted the proceeding, or a motion to dismiss without prejudice filed by a party who instituted the proceeding but prior to the filing of any other party’s filing of a responsive pleading. Upon the filing of such a motion to dismiss, the administrative law judge may forego all recommendation procedures and prepare an appropriate order of dismissal for issuance by the Commission.

IT IS THEREFORE ORDERED:

That Docket Number T-37667 is DISMISSED with prejudice.
