REPORT OF STATUS CONFERENCE

A status conference was convened in this proceeding on July 9, 2024, before Administrative Law Judge Melissa Frey. Participating in the status conference were:

Landon Yarborough and Fred Owens, telephonically, on behalf of Trophy Trucking Services, LLC (“Applicant”); and

Justin Bello and Tammy Burl on behalf of the Louisiana Public Service Commission (“Commission”) Staff.

Mr. Owens provided an overview of the application filed in this matter. Mr. Bello advised the Tribunal that discovery is ongoing. The Tribunal provided an overview of the procedural process for waste applications. The parties then discussed and agreed to a procedural schedule. Accordingly,


All parties intending to present evidence at the hearing shall bring a copy of each exhibit for the court reporter, as well as additional copies for the judge, the research attorney, and all other parties to the proceeding. Hearing exhibits presented to the court reporter for admission into the hearing record shall be single-sided.

Any party seeking a continuance of the hearing date must file a motion for the continuance by **August 20, 2024**. The motion must also contain a statement (1) affirming that the moving party has contacted all other parties to the case concerning the proposed continuance and (2) advising of the position of each of the other parties to the proposed continuance. Motions for continuance filed after this date will be considered only upon a showing of good cause for the delay.

If you require special accommodation at the hearing, please contact the Administrative Hearings Division at (225) 219-9417 at least five days prior to the date of the hearing.

Public parking is available in the Galvez Garage across North Street from the Galvez Building. The Office of State Buildings uses a gateless license plate reader in the Galvez Garage.
