After review of the record, the Louisiana Public Service Commission Staff ("Staff") states that the following actions have occurred in the above-referenced matter:

- (1) The application submitted by DISH Wireless L.L.C. ("DISH") and Republic Wireless, Inc. ("Republic") regarding a proposed transaction involving the transfer of certain assets and customers from Republic to DISH was filed on March 21, 2021.
- (2) Notice of the filing was published in the Commission's Official Bulletin No. 1241 on March 19, 2021.
- (3) The intervention period in this docket expired on April 4, 2021 without intervention or protest of any party in interest.

This letter is intended to acknowledge that Staff has reviewed the above-docketed matter. Additionally, at present there are no outstanding compliance issues involving the Company.
