RE: Insurance

Your Common Carrier Certificate Nos. 8489 & 8548 have been flagged for failure to maintain the required insurance coverage on file with the Commission. In accordance with the Commission's General Order dated October 13, 2023, intrastate carriers must maintain proof of the required insurance coverage on file at the Commission at all times. Should the carrier fail to maintain such filings, the Commission may pursuant to La. R.S. 45:166, revoke the carrier's certificate.

A letter was mailed to your company on November 6, 2023, requesting a new Form E filing. On November 13, 2023 a Form E was filed with an effective date of September 22, 2023. The Form E was unacceptable due to the lapse that occurred from *September 19, 2023 to September 22, 2023*. Another letter was mailed to you on February 6, 2024, requiring you to submit a notarized affidavit stating the dates of the lapse in coverage, the reason for the lapse in insurance coverage and that you were not operating or had proper insurance during this period. A blank *Insurance Affidavit* is attached. Please complete in front of a notary and submit to our office.

You have tentatively been scheduled to appear at a hearing on <u>Thursday June 06, 2024</u> at 9:30 a.m., before a Louisiana Public Service Commission Administrative Law Judge to show cause why an order should not be issued by the Commission canceling your Common Carrier Certificate Nos. 8489 & 8548 for failure to maintain the required insurance coverage on file with the Commission; and for further order or orders as the Commission may deem necessary in the premises.

If the required insurance coverage is not received by **April 02, 2024**, the Commission will proceed to issue a citation where Commission Staff will present testimony and evidence in support of its allegations against you. Once you company is cited a TWENTY FIVE DOLLAR (\$25.00) citation fee will be assessed. If you have any questions regarding this matter please contact our office at (225) 342-1424.

We must have a <u>notarized affidavit</u> stating the dates of the lapse in coverage, the reason for the lapse in insurance coverage and that you were not operating during this period. A *blank Insurance Affidavit is attached please complete in front of a notary and submit to our office.* 

**<u>REMEMBER</u>**, ALL insurance filings must read **EXACTLY** as your certificate, as listed in the heading of this letter. No abbreviations, or any misspellings, etc. are accepted unless it is listed on the certificate in the same manner.

There is a flag on your account and this could lead to the cancellation of your authority. A *notarized affidavit* must be received within <u>30 days</u> of the date of this letter or the cancellation process will <u>begin</u>. After reviewing our records, we found that the Form E filing is not current. The Commission received an Acord Certificate that has a different policy number and insurer than the Form E on file. The Acord also shows that policy number AQ2YLA001231-01expired on September 19, 2023. The Acord received on November 6, 2023 has a different policy number and insurer with an effective date of September 22, 2023, policy number 62P101320-00 from GuideOne Insurance Company.

**<u>REMEMBER</u>**, ALL insurance filings must read **EXACTLY** as your certificate, as listed in the heading of this letter. No abbreviations, or any misspellings, etc. are accepted unless it is listed on the certificate in the same manner.

Pursuant to General Order dated October 13, 2023 <u>please have your insurance underwriter promptly file a</u> <u>current, correct Form E within fifteen (15) days of the date of this letter</u> or the cancellation process will <u>begin</u>. If the filing shows a lapse then a notarized affidavit will also be required. The Form E filing may be emailed to <u>ins@la.gov</u>, mailed to LPSC – Transportation Division, P.O. Box 91154, Baton Rouge, LA 70821 or filed electronically.
