In Re: Rulemaking Docket to Consider Whether or Not the Commission Should Exercise Authority Over Future Utility Generation Deactivation and Retirement Decisions and the Rules and Procedures that Could Apply to Any Such Exercise of Authority (LPSC Docket No. R-34407)

Dear Ms. Abel:

Entergy Louisiana, LLC ("ELL" or the "Company") respectfully submits this annual compliance filing regarding ELL's ratemaking and accounting treatment of its retired and deactivated plants. This annual compliance filing is being submitted to comply with General Order 10-19-2018, Docket No. R-34407 (the "Deactivation Order"), issued by the Louisiana Public Service Commission ("Commission") on October 19, 2018. ELL reports that there was no change in the ratemaking or accounting treatment associated with Sterlington 7B,¹ Sterlington 7C,² Nelson 4,² Waterford 1,³ and Nelson 1 & 2⁴ over the past year.

In December 2024, the Company made the Commission aware of ELL's decision to retire Sterlington 7A—effective January 1, 2025.⁵ The Company also reported that once Sterlington 7A was retired, ELL would remove the plant balance from Federal Energy Regulatory Commission

("FERC") Account 101 by crediting FERC Account 101 and debiting FERC Account 108, Accumulated Provision for Depreciation of Electric Plant, for the gross plant value. ELL further noted that any difference between the gross plant value and depreciation recorded life-to-date would remain in FERC Account 108 to be addressed in ELL's next depreciation study. Subject to that information, ELL reports no other changes in the ratemaking or accounting treatment associated with Sterlington 7A.
