**WHEREAS**, RPS is the business of hauling salt water in oilfield operations under LPSC authority #8577 and hauling oilfield and industrial waste under PSC authority #8600, amongst other lines of business.

**WHEREAS**, Mr. James R. Moore is deceased as of December 27, 2024 and the executor of Mr. Moore's estate is Codi M Brown.

**WHEREAS**, Codi M Brown, executor, appointed herself as the manager of ARM LLC and appointed Mr. John Wade Whitty as manager of RPS.


**WHEREAS**, the Managers of RPS, ARM, LLC and John W Whitty, by meeting, voted to cease any and all business operations which fall under LPSC authority, effective immediately, and to sell those assets used in the business.


Accordingly, the following matters were duly adopted and approved and such approval is now in full force and effect:
