A CERTIFICATE IS HEREBY GRANTED TO **OEG OFFSHORE, INC.** whose office or place of business is at **CAMERON, LOUISIANA** authorizing operations in Louisiana intrastate commerce as a COMMON CARRIER OF SPECIAL COMMODITIES OVER IRREGULAR ROUTES by motor, handling the following described commodities, in territories described:

Restricted to the transportation of waste water resulting from the cleaning of tanks owned by OEG Offshore, Inc. and cleaned in their facility located at 111 Garber Street, Cameron, Louisiana or resulting from the cleaning of tanks owned by third parties cleaned at their facilities, including boats and barges owned by third parties, and located in Cameron, Calcasieu, Lafourche, Jefferson Davis, Acadia, Vermillion, and St. Mary parishes of Louisiana for disposal at New Park or U.S. Liquids (formerly Trinity Environmental) or ETT Environmental in Cameron, Louisiana.
