In re: Alleged violation of 1) General Order dated July 12, 2013 for failure to provide a written estimate prior to conducting moving services and 2) General Order dated July 01, 2021 as amended by exceeding rates as outlined in the company's tariff dated June 27, 2013, while operating under Common Carrier Certificate Number 7823 allegedly having occurred on or about October 18, 2021 through October 20, 2021.

**RULING ON MOTION TO CONTINUE
AND
NOTICE OF RESCHEDULED HEARING DATE**

On March 29, 2022, Fast Affordable College Student Movers, Inc. ("Carrier") filed a Motion and Order to Continue ("Motion to Continue"), requesting that the hearing scheduled on April 1, 2022 be continued to a later date. The Motion to Continue stated that the Louisiana Public Service Commission ("Commission") Staff opposed the Motion to Continue. 

2. The Records and Recordings Division must receive the request at least five (5) business days prior to the hearing date;
3. The request must contain the proceeding's docket number and the name of the party requesting the continuance; and
4. The request must also contain good cause for the requested continuance.
