NOTICE OF INTERVENTION AND INCLUSION ON SERVICE LIST**

Packaging Corporation of America ("PCA") submits this notice of intervention in the captioned proceeding pursuant to Rule 10 of the Louisiana Public Service Commission ("LPSC" or "Commission") Rules of Practice and Procedure and based on the following grounds:

1 .

This proceeding was initiated when Cleco Power LLC ("Cleco Power") filed an application seeking authorization of a restructuring of British Columbia Investment's ("BCI") ownership interest in Cleco Power. Notice of the proceeding was published in the LPSC's Official Bulletin No. 1230, with interventions due on or before Monday, November 2, 2020. Thus, this Notice of Intervention is timely filed.

Rule 10 of the LPSC Rules of Practice and Procedures provides that any party actually in interest may appear in any proceeding before the LPSC.

PCA is a publicly traded company headquartered in Lake Forest, Illinois. PCA owns and operates a containerboard mill in DeRidder, Louisiana that is served by Cleco.

PCA's DeRidder, Louisiana mill is one of Cleco's largest customers. As a ratepayer of Cleco's rates and charges, PCA has a substantial interest in the outcome of this proceeding.

No other party to this proceeding is suited to adequately represent PCA's interests. Accordingly, PCA seeks to intervene and participate in this docket as a full party intervenor.

This intervention will not prejudice any other party or unduly delay the proceedings with respect to the examination of the issues presented by this proceeding.
