**ORDER OF DISMISSAL**

The Louisiana Public Service Commission (“Commission”) issued a citation to Twin City Towing, LLC (“Carrier”) dated November 15, 2023 directing the Carrier to appear at a hearing on January 11, 2024 to show cause why its Common Carrier Certificate Number 7274 should not be canceled due to the Carrier’s failure to obtain 2023 vehicle identification stamps, as required by La R.S. 45:161 through 180.1, and to pay a citation fee of \$25.00. Notice of the proceeding was published in the Commission’s *Official Bulletin* on November 22, 2023. On December 22, 2023, the Commission Staff filed a *Motion to Dismiss* requesting that this matter be dismissed with prejudice as all issues have been resolved.

This dismissal is prepared in accordance with Rule 56(d) of the Rules of Practice and Procedure of the Commission, which provides:

Except at the discretion of the administrative law judge, the procedures contained within subpart (a) of this Rule shall not apply to a motion to dismiss jointly filed by all parties of record, a motion to dismiss with prejudice filed by the party who instituted the proceeding, or a motion to dismiss without prejudice filed by a party who instituted the proceeding but prior to the filing of any other party’s filing of a responsive pleading. Upon the filing of such a motion to dismiss, the administrative law judge may forego all recommendation procedures and prepare an appropriate order of dismissal for issuance by the Commission.

IT IS THEREFORE ORDERED:

That Docket Number T-37048 be, and hereby is, DISMISSED with prejudice.
