NOTICE OF INTERVENTION AND INCLUSION ON SERVICE LIST

Packaging Corporation of America ("PCA") submits this notice of intervention in the captioned proceeding pursuant to Rule 10 of the Louisiana Public Service Commission ("LPSC" or "Commission") Rules of Practice and Procedure and based on the following grounds:

1.

This rulemaking proceeding was initiated pursuant to a directive at the LPSC's November 17, 2021 Business and Executive Session, to open a rulemaking to assess the status and maintenance of the electric grid serving Louisiana, investigate whether certain storm costs could have been avoided with more preemptive maintenance of the grid throughout the state, and provide recommendations to the LPSC that would benefit Louisiana customers in reliability, decreased load pockets and access to resources outside of Louisiana's load zone. Notice of this proceeding was published in the LPSC's Official Bulletin Number 1261 (Corrected), dated December 23, 2021. Interventions are due on or before January 18, 2022.

Rule 10 of the LPSC Rules of Practice and Procedures provides that any party actually in interest may appear in any proceeding before the LPSC.

This intervention will not prejudice any other party or unduly delay the proceedings with respect to the examination of the issues presented by this proceeding.


