AFFIDAVIT AND STIPULATION

I, **Christopher J. Douresseaux** who is authorized to enter into this agreement on behalf of CJ's Towing 2 LLC herein admit that CJ's Towing 2 LLC violated Louisiana Revised Statute 45:161 through 180.1, by operating intrastate without LPSC authority; allegedly occurring on or about October 11, 2024. As a result, and in the interest of resolving with this matter with Louisiana Public Service Commission ("LPSC") Staff, I agree to the following:

1. Entering a guilty plea to Docket Number T-37439 for CJ's Towing 2 LLC operating intrastate without LPSC authority in violation of La. R.S. 45:161 through 180.1.
2. The imposition of a \$500.00 fine and a \$25.00 citation fee with \$250.00 of the fine being suspended contingent on ceasing to operate and offer services as CJ's Towing 2 LLC. All fines and fees must be paid in certified funds and are due to be paid no later than January 8, 2025 at 4:30 PM
3. I understand that I must cease operating and offering services as CJ's Towing 2 LLC to the until such time as a Common Carrier Certificate is issued to CJ's Towing 2 LLC;

4. Execute this Affidavit and Stipulation before a notary and return to LPSC Transportation Staff by January 8, 2025;

5. I further understand that failure to comply with any of the above requirements will result in the \$250.00 suspended portion of the fine becoming due immediately.
