NOW BEFORE THIS COMMISSION, comes and appears SOUTHWEST LOUISIANA ELECTRIC MEMBERSHIP CORPORATION (SLEMCO), who for the purpose of intervening in the captioned cause avers as follows, to-wit:

1.

SLEMCO is a rural electric cooperative, domiciled in Lafayette Parish, Louisiana, organized and existing pursuant to the laws of the State of Louisiana.

2.

On May 21, 2020, the Louisiana Public Service Commission Staff issued a Notice of Proceeding initiating the docket pursuant to directive issued by Commissioner Skrmetta at the February 19, 2020 Business and Executive Session. The notice of this proceeding was published in its June 12, 2020 Official Bulletin No. 1221, with the deadline for interventions to be filed within twenty-five (25) days after publication or by July 7, 2020. Therefore, the intervention period has not lapsed and this Motion to Intervene is timely.

3.

SLEMCO serves electricity to approximately 100,000 consumers in the southwest Louisiana parishes of Lafayette, St. Martin, Vermilion, Acadia, St. Landry, Jefferson Davis, Evangeline, Iberia, and Avoyelles; therefore the matters to be considered by the Commission in this docket could affect the operations and rates of SLEMCO. SLEMCO wishes to participate in this docket.

4.

Rule 10 of the Commission's Rules of Practice and Procedure allows any party with a justifiable or administratively cognizable interest to intervene in any proceeding before the Commission.

5.

No other party to this proceeding is suited to adequately represent SLEMCO's interests. Accordingly, SLEMCO seeks to intervene and participate in this docket as a full party intervenor.
