Dear Mrs. Britton and Mr. Ortiz:

Pursuant to Section 252(e) of the Telecommunications Act of 1996 (47 U.S.C. § 252(e)), the Louisiana Public Service Commission ("Commission") notifies Lafourche Telephone Company, LLC and Teleport Communications America, LLC (collectively, the "Companies"), of the following:

- 1. On October 23, 2020, the Commission received from the Companies a Request for Approval of an Interconnection Agreement Pursuant to Section 252(e) of the Telecommunications Act of 1996 ("Request").
- 2. The Request was published in the Commission's Official Bulletin No. 1231 dated October 30, 2020.
- 3. The intervention period expired on November 24, 2020.
- 4. The Commission received no intervention or opposition during the intervention period.

- 5. Pursuant to Section 252(e) of the Telecommunications Act of 1996 (47 U.S.C. § 252(e)):
  - a. The Commission has not found that the Interconnection Agreement discriminates against a telecommunications carrier not a party to the Agreement.
  - b. The Commission has not found that the Interconnection Agreement is inconsistent with the public interest, convenience, or necessity.

Accordingly, the Request for Approval of an Interconnection Agreement between the Companies is deemed **approved**. This letter closes this docket, and no further action will be taken.
