Transportation of:

- liquid mud and treated fluids utilized in the discovery, development, drilling, completion, maintenance, and production of oil, gas and other petroleum products to and from Francis Drilling Fluids, Ltd. Storage facilities to and from all points in Louisiana;
- (2) liquid mud and fluids utilized in the discovery, development, drilling, completion, maintenance, and production of oil, gas and other petroleum products, nut which are not reuseable and are considered disposable, from all locations within the State which have been serviced by Francis Drilling Fluids, Ltd. Within 30 days of the request for the transportation services to all points in Louisiana.

Restricted against transportation of dry bulk materials in pneumatic tank trucks.
