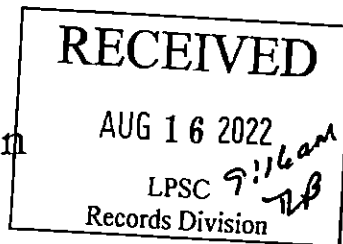

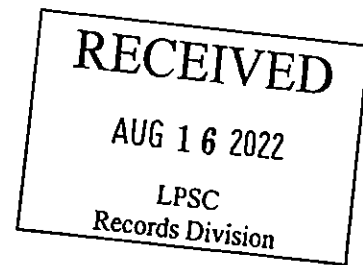

MOTION TO INTERVENE AND REQUEST FOR

The Southern Renewable Energy Association (SREA), pursuant to Rule 10 of the Louisiana Public Service Commission ("LPSC") Rules and Practices and Procedures, hereby requests to intervene in the captioned proceeding suggesting as follows:

1.

On August 5, 2022, the LPSC published Official Bulletin #1277, opening Docket I-36503, 1803 Electric Cooperative, Inc.'s 2022 Request to Initiate Integrated Resource Planning Process Pursuant to the General Order (Corrected) in Docket R-30021 Dated April 20, 2012.

SREA is a utility-scale renewable energy trade association to promote responsible use and development of renewable energy in the South. SREA's region includes Alabama, Arkansas, Georgia, Florida, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, Tennessee, and Virginia. SREA's members are engaged in developing utility-scale solar energy, wind energy, energy storage and/or renewable energy-related transmission and infrastructure development, and/or providing accurate information regarding such development and use that affects the SREA region.

Previously, the LPSC granted SREA's motions to intervene in several IRP dockets, including processes for Cleco, Entergy Louisiana, and Southwestern Electric Power Company. SREA's intervention in this proceeding will not prejudice any other party, and will not delay the progress of this proceeding.

No other party to this proceeding is suited to adequately represent SREA or its members' interests. Therefore, SREA possesses standing to intervene and requests formal intervenor status in this proceeding.




