SHARE TRANSFER AGREEMENT

THIS SHARE TRANSFER AGREEMENT (this "Agreement") is made as of the 1st day of February, 2021, between Deborah F. Luther ("Buyer"), who has a mailing address of 463 Hickory Drive, Slidell, Louisiana 70458, and Jennifer J. Mizell ("Seller"), who has a mailing address of 43178 Cannon Road, Gonzales, Louisiana 70737.

RECITALS

A. Kirby Faciane, Inc., a Louisiana corporation (the "Corporation"), was founded on December 30, 1983 by Kirby Faciane.

B. The Corporation is currently owned by the Buyer and the Seller, each holding a fifty percent (50%) interest. The stock ledger of the Corporation has not been maintained, and there are no outstanding stock certificates representing these interests.

C. Buyer wishes to purchase, and Seller wishes to sell, all of Seller's interest in the Corporation, so that Buyer shall be the sole owner of the Corporation. Buyer and Seller have agreed to a sale of the Seller's interest in the Corporation, subject to the terms and conditions of this Agreement.

TERMS AND CONDITIONS

1. **Transfer of the Shares.** The Seller hereby transfers her entire right, title and interest in the Corporation, which is a fifty percent (50%) uncertificated interest, to the Buyer, for a purchase price of Fifty Thousand Dollars [REDACTED], to be paid as follows: Twenty Thousand Dollars [REDACTED] on the date of execution of this Agreement, with the balance to be paid in six (6) monthly installments of Five Thousand Dollars [REDACTED], commencing thirty-one (31) days after the date of execution of this Agreement and continuing on the same day of each month thereafter until paid in full.

2. **Resignation and Renunciation.** The Seller hereby resigns any position she may hold as an officer or director of the Corporation, and renounces any further right that she may have, if any, either financial or administrative, arising from her status as shareholder.

3. **Warranties and Representations.** The Seller hereby warrants and represents to the Buyer that:

(a) She is the sole legal and beneficial owner of the interest transferred herein;

(b) The interest transferred herein is free all of liens, claims and encumbrances;

(c) Seller has the right, power and authority to execute and deliver this Agreement and perform her obligations under this Agreement;

(d) This Agreement, when executed, will constitute the Seller's legal, valid and binding obligation, enforceable in accordance with its terms; and

(e) No consent, authorization, license or approval of or notice to any governmental, administrative, judicial or regulatory body, authority or organization or any other person is required to authorize the execution, delivery, validity or enforceability of this Agreement or the Seller's performance of her obligations under this Agreement.

4. Indemnification. Seller hereby indemnifies, defends, and holds Buyer harmless against the claims of any person asserting an interest in the Corporation purportedly obtained through, by or from Seller, or as a result of any transaction or relationship that such person had or has with Seller.

5. Entire Agreement. This Agreement constitutes the whole and only agreement between the parties relating to the subject matters hereof and supersedes and extinguishes any prior drafts, agreements, undertakings, representations, warranties and arrangements of any nature whatsoever, whether or not in writing, relating thereto. Each party to this Agreement acknowledges that in entering into this Agreement she is not relying upon any representation, warranty, promise or assurance made or given by the other party or any other person, whether or not in writing, at any time before the execution of this Agreement, except as may be expressly set out herein.

6. Further Assurances. Each party to this Agreement shall from time to time, on being required to do so by the other party to this Agreement, now or at any time in the future, do or procure the doing of all such acts and execute or procure the execution of all such documents in a form satisfactory to such requesting party as that requesting party may reasonably consider necessary for giving full effect to this Agreement and securing to that requesting party the full benefit of the rights, powers and remedies conferred upon that requesting party in this Agreement.

7. Amendments. No purported modification or amendment of this Agreement shall be effective unless it is in writing, refers specifically to this Agreement and is duly executed by each party to it.

8. Counterparts. This Agreement may be executed by the parties on separate counterparts, each of which shall be deemed to be an original, but which, taken together, shall constitute one and the same instrument.

9. Costs. Each of the parties to this Agreement shall pay her own legal and other costs and expenses in connection with the negotiation, preparation, execution and performance of this Agreement.

10 Governing Law and Jurisdiction. This Agreement shall be governed by and construed in accordance with the laws of the State of Louisiana. The parties to this Agreement irrevocably agree that the 22nd Judicial District Court for the Parish of St. Tammany, State of Louisiana, shall be the exclusive venue to settle any disputes which may arise out of or in connection with this Agreement and that accordingly any petition regarding any such dispute may be filed only in such court.
