Dear Secretary Frey:

I am writing to inform the Louisiana Public Service Commission (hereinafter referred to as the "**Commission**" or the "**LPSC**") that Ascension Water Company (hereinafter referred to as "**Ascension**"), which currently purchases water from Baton Rouge Water Company (hereinafter referred to as "**BRWC**"), has been affected by rate increases recently approved by the LPSC for BRWC (LPSC Order No. U-37129<sup>1</sup>). Accordingly, Ascension must adjust its water tariff on file with the Commission. The applicable BRWC increase is detailed below. Please find enclosed a copy of correspondence from BRWC concerning this rate change.

Please note that this request is not a request for a rate increase. This is simply a pass through of a rate increase previously approved by the LPSC for BRWC. Out of an abundance of caution and to provide notice to Ascension's customers, notice of this request will be published in the parish journal for the parishes affected as well as the statewide journal attesting to this request

for an increase in the flow-through rate. Proof of such publication will be submitted to the Commission upon receipt. Accordingly, Ascension is making this formal request that the Commission issue a Letter of Non-Opposition authorizing the increase of the flow-through rate for water services in accordance with the below schedule, effective immediately.

• Water purchased from BRWC has increased to \$0.645 (previously \$0.585) per 1,000 gallons, effective September 6, 2024.

Company also respectfully requests that Notice of this filing be published in the Commission's Official Bulletin, No. 1332, and interested parties be given <u>fifteen (15) days</u> to file any notice of intervention and/or protest.
