CODY JAMES BLANCO (SSN xxx-xx-8212), husband of Lauren Davis, a resident of and whose mailing address is 700 Jake St., Patterson, LA 70392

who, acting under the authority of Louisiana's Limited Liability Company Law (Act 780 of 1992, RS 12:1301 et seq), does enter into the following contract for the formation of a Limited Liability Company:

1. NAME - The name of the Limited Liability Company shall be Rick's Auto, L.L.C. sometimes hereafter called "the company".

2. PURPOSES - The company's purpose is to engage in any lawful activity for which Limited Liability Companies may be formed under Chapter 22 of Title 12 of the Louisiana Revised Statutes.

3. The affairs of this limited liability company shall be managed by its Members. The initial members of this limited liability company are Cody Blanco and Jeffrey Boudreaux. The authority of the Members to bind this limited liability me be set forth in a written operating agreement.

- (a) establish the membership of any member of the company,
- (b) establish the authenticity of any records of the company

or

- (c) establish the authority of any person to act on behalf of Rick's Auto, L.L.C. including but not limited to the authority to take actions referred to in Louisiana Revised Statutes Title 12, Section 1318(B), which actions include:

- (1) The dissolution and winding up of the company,
- (2) The sale, exchange, lease, mortgage, pledge, or other transfers of all or substantially all of the assets of the company,
- (3) The merger or consolidation of the company,
- (4) The incurrence of indebtedness by the company other than in the ordinary course of its business.
- (5) The purchase of any immovable by the company, or sale, alienation, lease, mortgage, pledge or encumbrance, of any immovables of the company, and
- (6) An amendment to the articles of organization.




