Should the carrier fail to maintain such filings, the Commission may pursuant to La. R.S. 45:166, revoke the carrier's certificate.

- A letter was mailed to your company on September 3, 2020, requesting a new, current Form E filing. As of October 21, 2020, a *new Form E for Commercial Auto Liability Insurance* has not yet been received.

**You have tentatively been scheduled to appear at a hearing on Thursday, January 7, 2021 at 9:30 a.m.,** before a Louisiana Public Service Commission Administrative Law Judge to show cause why an order should not be issued by the Commission canceling your **Common Carrier Certificate Number 7962** for failure to maintain the required insurance coverage on file with the Commission; and for further order or orders as the Commission may deem necessary in the premises.

If the required insurance coverage is not received by **November 13, 2020**, the Commission will proceed to issue a citation where Commission Staff will present testimony and evidence in support of its allegations against you.
