The hearing will be held at the Louisiana Public Service Commission, Galvez Building, 11th Floor, 602 North 5th Street, Baton Rouge, Louisiana, 70802. Parking is available in the Galvez Parking Garage across from the Galvez Building on North Street. ***Furthermore, a citation fee in the amount of \$25.00 has been assessed to your LPSC account.***

TO SHOW CAUSE, if any you have or can, why an order should not be issued by the Commission canceling your Cancellation of **Common Carrier Certificate No. 5958** for failure to file an Annual Report for 2023 and/or pay a late filing fee of \$500.00 and a citation fee of \$25.00 as required by General Order 2 dated July 01, 1921 and General Order dated March 18, 2021; and for further order or orders as the Commission may deem necessary in the premises.

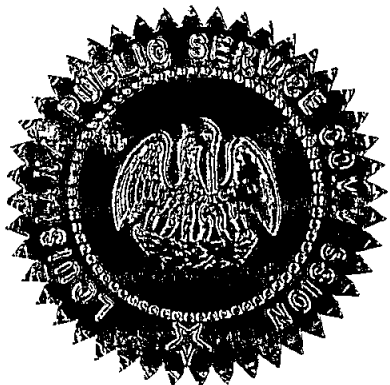


You have tentatively been scheduled to appear at a hearing August 21 or 22, 2024 at 9:30 am, before a Louisiana Public Service Commission Administrative Law Judge to show cause why an order should not be issued by the Commission canceling your authority for failure to timely file your Annual Report as required by General Order 2 dated July 1, 1921 and General Order dated March 18, 2021.

If BOTH the ANNUAL REPORT and FIVE HUNDRED DOLLAR (\$500.00) late fee are not received by **June 14, 2024** the Commission will proceed to issue a citation to appear at the above mentioned hearing and a TWENTY FIVE DOLLAR (\$25.00) citation fee will be assessed.

Furthermore, pending filing of the report and/or late fee, no applications, tariffs, leases or other filings will be accepted, and no vehicle identification stamps or cab cards will be issued.
