



ARTICLE I

Name

The name of the corporation is: A. Maloney Moving &
 Storage, Inc.

ARTICLE II

Purpose

The purpose of the corporation is to engage in any lawful
 activity for which corporations may be formed under the Business
 Corporation Law.

ARTICLE III

Capital

This corporation has authority to issue an aggregate of
 10,000 shares of capital stock, all of which are designated common
 stock having No Par Value per share.

ARTICLE IV

Preemptive Rights

Shareholders shall have preemptive rights.

ARTICLE V

Shareholders' Consents

Whenever the affirmative vote of shareholders is required

of the total voting power on the question which is required by law or by these Articles of Incorporation, whichever requirement is higher, shall be sufficient for the purpose, without necessity for a meeting of shareholders.

ARTICLE VI

Directors

Section 1. Number of Directors. The number of directors of the corporation shall be such number, not less than three nor greater than five, as shall be elected from time to time by the shareholders, except that when all of the outstanding shares are held of record by fewer than three (3) shareholders, there need be only as many directors as there are shareholders.

Section 2. Director's Proxies. Any director absent from a meeting of the Board of Directors or any committee thereof may be represented by any other director or shareholder, who may cast the vote of the absent director according to the written instructions, general or special, of the absent director.

ARTICLE VII

Revision

Cash, property or share dividends, shares issuable to shareholders in connection with a reclassification of stock, and the redemption price of the redeemable shares, which are not claimed by the shareholders entitled thereto within one year after the dividend or redemption price became payable or the shares became issuable, despite reasonable efforts by the corporation to pay the dividend or redemption price or deliver the certificates for the shares to such shareholders within such time, shall, at the expiration of such time, revert in full ownership to the corporation, and the corporation's obligation to pay such dividend or redemption price or issue such shares, as the case may be, shall thereupon cease; provided that the Board of Directors may, at any time, for any reason satisfactory to it, but need not, authorize (a) payment of the amount of any cash or property dividend or redemption price or (b) issuance of any shares, ownership of which has reverted to the corporation pursuant to this Article VII, to

the entity who or which would be entitled thereto had such reversion not occurred.

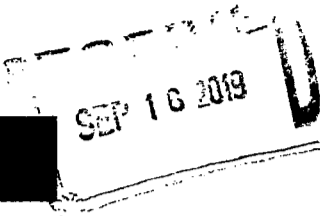

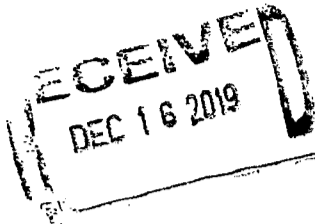
