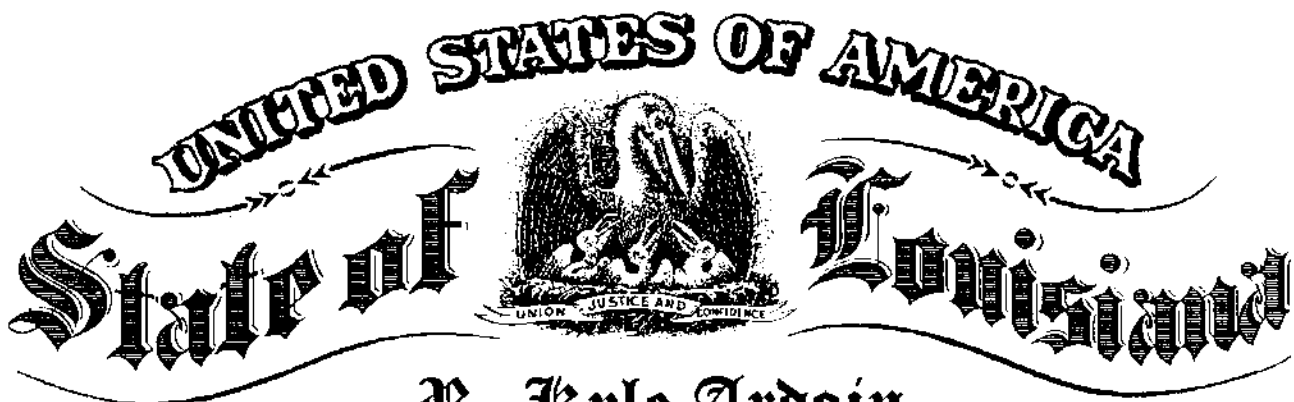


3. **MANAGEMENT** - The company shall be managed by managers. JOSHUA L. ARABIE shall serve as the sole manager for a perpetual term.
