Household goods within 150 miles of Metairie.

Furniture and appliances from retail outlets for residential deliveries, only, within 100 miles of Metairie.

No shipment shall exceed 1,500 pounds.

Restricted to the use of vehicles not in excess of two (2) axles.

Restricted to not more than five (5) company owned vehicles; owner-operators or leased vehicles are prohibited.


This authority shall not be amended, leased or transferred for a period of five (5) years from date of issuance of certificate.
