ORDER NO. U-36174-A - 7/3/2024 - Southwestern Electric Power Company, ex parte. In re: Application for Recovery of Certain Storm Damage Costs Incurred as a Result of Hurricane Laura and Delta and the February 2021 Winter Storm Event, related securitization financing, establishment of a storm reserve, and for recovery of storm damage costs associated with the June 2023 storms. Order No. U-36174-A accepts the Uncontested Stipulated Settlement filed on April 24, 2024, which determines that SWEPCO's request to securitize costs relative to Hurricanes Laura and Delta, and Winter Storm Uri, is reasonable and prudent, subject to conditions. The vote occurred at the Commission's June 19, 2024 Business & Executive Session.

ORDER NO. U-36174-B - 7/3/2024 - Southwestern Electric Power Company, ex parte. In re: Application for Recovery of Certain Storm Damage Costs Incurred as a Result of Hurricane Laura and Delta and the February 2021 Winter Storm Event, related securitization financing, establishment of a storm reserve, and for recovery of storm damage costs associated with the June 2023 storms. Order No. U-36174-B is the Financing Order relative to SWEPCO's request to securitize costs associated with Hurricane Laura and Delta and the February 2021 Winter Storm Event. The vote occurred at the Commission's June 19, 2024 Business & Executive Session.

ORDER NO. U-36923 - 7/17/2024 - Cleco Power LLC, ex parte. In re: Request for: 1) implementation of change in rates with an effective date of July 1, 2024; and 2) extension of existing Formula Rate Plan. Order No. U-36923 accepts the Uncontested Stipulated Settlement filed into the record on May 31, 2024, which allowed for a change in revenue requirements, extension of the Formula Rate Plan for a period of 3 years, a change in rate design, and provided for other commitments as detailed therein.
