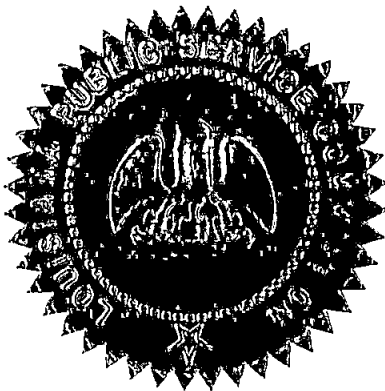

Your **Common Carrier Certificate No. 8528** has been flagged for failure to maintain the required insurance coverage on file with the Commission. In accordance with the Commission's General Order dated October 13, 2023, intrastate carriers must maintain proof of the required insurance coverage on file at the Commission at all times. Should the carrier fail to maintain such filings, the Commission may pursuant to La. R.S. 45:166, revoke the carrier's certificate.

- On December 05, 2023 the Commission received a Form K showing a cancellation date of January 09, 2024 for your Commercial Auto Liability Insurance. A letter was mailed to your company on January 12, 2024, requesting a new Form E filing. As of the date of this letter, a *new Form E for Commercial Auto Liability Insurance* has not yet been received.

**You have tentatively been scheduled to appear at a hearing on Thursday May 09, 2024 at 9:30 a.m., before a Louisiana Public Service Commission Administrative Law Judge to show cause why an order should not be issued by the Commission canceling your **Common Carrier Certificate No. 8528** for failure to maintain the required insurance coverage on file with the Commission; and for further order or orders as the Commission may deem necessary in the premises.**

If the required insurance coverage is not received by **March 04, 2024**, the Commission will proceed to issue a citation where Commission Staff will present testimony and evidence in support of its allegations against you. Once your company is cited a TWENTY FIVE DOLLAR (\$25.00) citation fee will be assessed. If you have any questions regarding this matter please contact our office at (225) 342-1424.
