SUMMARY OF CHANGES TO TARIFF XI

- The proposed tariff includes numerous changes both increasing costs for some items and services, and decreasing costs for others. These proposed changes more closely reflect the costs associated with the particular type of item or service.
- The proposed tariff attempts to more clearly reflect costs for full service pack and unpack, and custom service pack and unpack
- The proposed tariff proposes that break points be adjusted to result in lower costs for the customer.
- "CWT" is an industry term meaning per 100 pound or hundred-weight.
