**SPECIAL ORDER NO. 17-2025 - 4/21/2025** - 2025 Transportation Special Orders. Who Dat Transportation and Tours, LLC, ex parte. In re: Request for cancellation of LPSC NO. 8580. THEREFORE, IT IS ORDERED LPSC No. 8580 hereby is, cancelled.

**ORDER NO. T-37409 - 4/22/2025** - Louisiana Public Service Commission vs. Tiger Airport Shuttle, LLC. In re: Alleged violation of R.S. 45:161 through 180.1 and General Order dated April 25, 2012 by engaging in activities related to transporting passengers intrastate without LPSC authority. Order No. T-37409 accepts the Affidavit and Stipulation between Commission Staff and Tiger Airport Shuttle, LLC executed on February 26, 2025. **SPECIAL ORDER NO. 18-2025 - 4/23/2025** - 2025 Utility Special Orders. This Special Order ratifies LPSC interventions in Federal Energy Regulatory Proceedings regarding Regional Transmission Organization issues or Entergy Regional State Committee issues.

**ORDER NO. S-37410 - 4/15/2025** - Dixie Electric Membership Corporation, ex parte. In re: Request for Letter of Non-Opposition authorizing DEMCO to secure a loan for a four-year construction work plan and mortgage assets associated therewith. (Notice of intervention or protest shall be filed within 15 days of the date of this bulletin.) Order S-37410 accepts the Staff Report and Recommendation filed into the record on February 17, 2025, and the Commission expresses its non-opposition to Dixie Electric Membership Corporation's request for a Letter of Non-Opposition authorizing a loan in order to secure a loan for a four-year construction work plan and mortgage assets associated therewith subject to conditions within. This matter was considered at the March 26, 2025 Business and Executive Session

**ORDER NO. S-37461 - 4/22/2025** - Brightspeed of Louisiana, LLC and Brightspeed of South Arkansas, LLC. In re: Request for Letter of Non-Opposition to issuance of guarantees and pledge of assets as security in connection with Refinancing Agreement of parent Connect Holding II LLC. Docket No. S-37461 - On December 10, 2024, the Louisiana Public Service Commission received a request for an order of approval or non-opposition from Brightspeed of Louisiana, LLC and Brightspeed of South Arkansas, LLC requesting approval or non-opposition to the Companies granting security interests in their respective assets in connection with Connect Holding II LLC's indirect parent, Connect Parent Corporation, adding the Companies as guarantors of Connect Holding II's new secured debt. The request was submitted pursuant to the Commission's General Order dated March 18, 1994, as amended. Notice of the Request was published in the Commission's Official Bulletin #1339 dated December 20, 2024, with a 15-day intervention period. No interventions were filed. Based on Staff's review of the Request and an analysis of the 18 factors set forth in the 1994 General Order, Staff recommended that the Commission issue an Order expressing its approval and/or non-opposition to the Proposed Security Interests, as they align with the public interest and do not negatively impact ratepayers or the Commission's jurisdiction. This matter was considered at the Commission's March 26, 2025 Business and Executive Session. On motion of Vice Chairman Skrmetta, seconded by Commissioner Lewis, and unanimously adopted, the Commission voted to adopt the Staff Report and Recommendation filed into the record on March 5, 2025.

**ORDER NO. U-37341-A - 4/15/2025** - Pointe Coupee Electric Membership Corporation, ex parte. In re: Application for increase of base rates, including request for interim rate relief, request for associated Tariff modifications, and request to establish a formula rate plan and emergency reserve fund. Order U-37341-A accepts Uncontested Stipulated Settlement filed into the record on September 27, 2024, which authorizes for Pointe Coupee Electric Membership Corporation to implement an increase of base rates, including request for interim rate relief, request for associated Tariff modifications, and request to establish a formula rate plan and emergency reserve fund in accordance with the terms contained therein. This matter was considered at the March 26, 2025 Business and Executive Session.
