AS A COMMON CARRIER OF SPECIAL COMMODITIES
OVER IRREGULAR ROUTES

A CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY IS HEREBY GRANTED TO JOHN MCGEE TRUCKING, LLC whose office or place of business is at DUBACH, LOUISIANA authorizing operations in Louisiana intrastate commerce as a COMMON CARRIER OF WASTE OVER IRREGULAR ROUTES by motor vehicle.

Transportation of non-hazardous oilfield waste over irregular routes in accordance with the following limitations:

1. Restricted to transportation in five (5) vacuum trucks.
2. Restricted to transportation of waste which originates north of a line drawn east and west across the State of Louisiana along the northern borders of Vernon, Rapides, Avoyelles, and West Feliciana Parishes.
3. Restricted against the use of leased or owner operator trucks under this Certificate.
4. John McGee Trucking, LLC is restricted against filing an application for additional or expanded authority to transport non-hazardous oilfield waste, non-hazardous industrial solid waste and hazardous waste for a period of two (2) years from the date of issuance this Certificate.

(Issued pursuant to Order No. T-33547 dated June 11, 2015. Except for cause beyond control, non-operation of an authority for a period of six (6) months could lead to its cancellation pursuant to La. R.S. 45:166, Paragraphs B and C.)

Said JOHN MCGEE TRUCKING, LLC shall perform such operations under tariffs now or hereafter filed with the Commission and in compliance with all laws and rules and regulations of the Commission bearing thereon.
