YOU ARE HEREBY NOTIFIED, COMMANDED AND REQUIRED to appear at a hearing on Thursday, March 5, 2026 at 9:30 a.m., before a Louisiana Public Service Commission Administrative Law Judge. The hearing will be held at the Louisiana Public Service Commission, Galvez Building, 11th Floor, 602 North 5th Street, Baton Rouge, Louisiana, 70802. Parking is available in the Galvez Parking Garage across from the Galvez Building on North Street.

TO SHOW CAUSE, if any, why you should not be found guilty by the Commission of alleged violation of La R.S. 45:161 through 180.1 by engaging in activities related to moving household goods prior to complying with the requirements of La. R.S. 45:164 (E) and General Order dated March 16, 2021 and for failure to comply with the requirements of General Order dated April 3, 2008 as amended; and for further order or orders as the Commission may deem necessary in the premises.

No later than fifteen (15) days before the date of the scheduled hearing, **any party** to this proceeding may request a **status conference** to discuss the issues herein. The request must be in writing and filed in the same manner as a request for continuance. At the hearing, the Commission Staff will present testimony and evidence in support of its allegations against you. You will be provided an opportunity to cross-examine Commission Staff's witness(es) and to present evidence and testimony in your defense. You will need to bring an original and four (4) copies of each document you wish to place into evidence.

Re: Advertising without LPSC authority

Mr. Pineda,

It has come to the attention of the Louisiana Public Service Commission that **AD Movers, LLC** (“**AD Movers**”) is advertising with the website: <https://admoversla.com/> which reflects advertising including the phone number listed as (504) 237-0855 and LPSC 8127. Please see printouts of this website, which are attached to this letter.

AD Movers’ Common Carrier Certificate No. 8127 (“LPSC 8127”) was cancelled on July 31, 2025. On August 1, 2025 our office mailed a letter notifying Ad Movers that LPSC 8127 was cancelled and that they were required to remove all advertising as a moving company. The letter also outlined all compliance filings that were required in order to get LPSC 8127 reinstated. As of the date of this letter, AD Movers has not attempted to get LPSC 8127 reinstated.

Therefore, AD Movers does not have the proper LPSC authority pursuant to General Order dated March 16, 2021 to offer household goods moving within the State of Louisiana and is prohibited by the Commission’s rules and regulations from advertising as such.

This letter serves as a warning for **AD Movers** to **CEASE ADVERTISING AND MOVING HOUSEHOLD GOODS IN LOUISIANA IMMEDIATELY**. The LPSC Staff intends to issue a citation ordering **AD Movers** to appear at a hearing on December 3, 2025 for violation of LA RS 45:164(E) and General Orders dated April 03, 2008 and March 16, 2021 if the household goods application to reinstate LPSC 8127 is not received in our office by **October 16, 2025**.
