A CERTIFICATE IS HEREBY GRANTED TO CODE 3 SERVICES, LLC whose office or place of business is at EL DORADO, ARKANSAS authorizing operations in Louisiana intrastate commerce as a COMMON CARRIER OF SPECIAL COMMODITIES OVER IRREGULAR ROUTES by motor, handling the following described commodities, in territories described:

Transportation of non-hazardous oilfield waste, non-hazardous industrial solid waste, and hazardous waste in accordance with the following limitations:

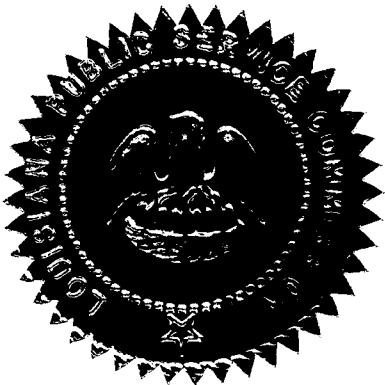
1. Restricted to transportation of waste originating north of a line drawn west to east across the northern borders of Vernon, Rapides, Avoyelles, Pointe Coupee, and West Feliciana Parishes.
2. Code 3 Services, LLC agrees that no application for additional or expanded authority shall be filed for a period of two (2) years from the date of issuance of this common carrier certificate.

(Issued pursuant to Order T-34045 dated October 1, 2016 and to L.R.S. 45:164 and the rules and regulations of the Louisiana Public Service Commission. Except for cause beyond control, non-operation of an authority for a period of six (6) months could lead to its cancellation pursuant to La. R.S. 45:166, Paragraphs B and C).

Said CODE 3 SERVICES, LLC shall perform such operations under prescribed rates or tariffs now or hereafter filed with the Commission and in compliance with all laws and rules and regulations of the Commission bearing thereon.


