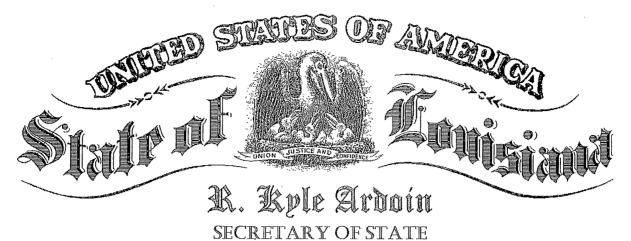

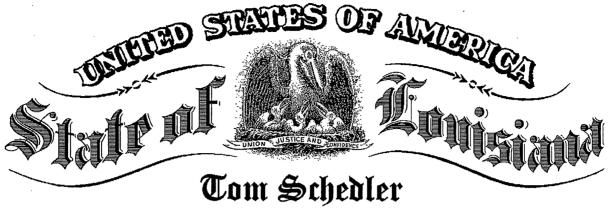

ARTICLES OF INCORPORATION

OF

PCM LEASING, INC.

BEFORE ME, the undersigned, a Notary Public in and for the Parish and State aforesaid, and in the presence of the undersigned competent witnesses, personally came and appeared:

CARLA D. FESI, of full age, married to and residing with Michael Fesi in Terrebonne Parish, with a mailing address of 129 Ciera Drive, Houma, LA 70364

Who declared that, availing herself of the benefits and provisions of the Constitution and Laws of Louisiana, and in particular the corporation laws being LSA R.S. 12:100 et seq, he does by these presents, form, organize and constitute a business corporation under the conditions, covenants and stipulations and agreements of the Articles following, to-wit:

ARTICLE I - NAME

The name of this corporation is PCM LEASING, INC.

ARTICLE II - OBJECTS AND PURPOSES

The purpose of this corporation is to conduct any lawful business activity permitted by the laws of the State of Louisiana.

ARTICLE III

The corporation shall have perpetual existence.

ARTICLE IV

This corporation is intended to be a small business corporation as defined and regulated by Louisiana law and is further intended to be formed and organized pursuant to Internal Revenue Code Section 1244.

ARTICLE V - REGISTERED OFFICE

The location and mailing address of the registered office of this corporation is 1246 BAYOU LACARPE ROAD, HOUMA, LA 70363, and all legal process shall be served upon the following registered agents:

ARTICLE VI - INCORPORATORS

The incorporators of this corporation are to be as follows:

CARLA D. FESI, 1246 BAYOU LACARPE ROAD, HOUMA, LA. 70363;

ARTICLE VII- AUTHORIZED SHARES

The corporation shall be authorized to issue 1000 shares of capital stock with no par value.

ARTICLE VIII - OFFICERS AND DIRECTORS

The first directors of this corporation shall be as follows: PRESIDENT -CARLA D. FESI;

SECRETARY -DENE' CUNNINGHAM.

The directors shall serve for a period of two (2) years or until their successors shall have been duly elected and qualified. Membership on the board shall be by nomination and election only. The members of the board shall be those persons nominated and elected by the stockholders at any regular or special meeting. Board members may serve consecutive terms of office without limit as to the number. The board shall meet quarterly at the registered office of the corporation or at such other times and places and at such frequency as the board in its own discretion desires and deems advisable. The officers of this corporation shall be a President, and a Secretary, who shall also serve as Treasurer. Vacancies occurring in the Board of Directors shall be filled by the remaining members of the board. The failure to elect directors or officers, or to hold meetings shall not be recorded as a forfeiture of this chapter.

ARTICLE IX - AMENDMENT OR LIQUIDATION

This chapter may be altered, amended or modified, or the corporation dissolved by a vote of three-fourths (3/4ths) of the stockholders present at a special meeting called for that purpose after seven (7) days previous notice thereof, in writing, shall have been given to each stockholder, either in person or by mail and in conformity with the corporation laws of Louisiana.

ARTICLE X - INDEMNIFICATION OF MEMBERS

Providing such members shall fully comply with the provisions of this article, the corporation shall indemnify each member of the board against all expenses, as hereinafter defined, which

shall necessarily or reasonably be incurred by such member in connection with any action, suit, or proceeding to which such member is or shall be a party, or with which such member may be threatened by reason of his being a member of this corporation. In order for the indemnification set forth herein to be provided, such member shall notify the corporation in writing of such claim, action, suit, or proceeding and shall give the corporation the right and power to defend the claim at the corporation's expenses and with counsel and/or other representatives of the corporation choosing. If, after proper notification, the corporation fails to defend such claim, action, suit or proceeding within a reasonable time then such member shall be entitled, at the expense of the corporation, to assume the defense and be empowered to settle the same matter subject however to the corporation's right to reassume the defense prior to final judgment or settlement. For purposes of this article expenses shall include amounts for which such member becomes liable as a result of a judgment against such member; it being specifically provided that expenses incurred in connection with any matters as to which such member is liable for willful misconduct in the performance of his duties, as a member shall not be included in the indemnification afforded herein.
