Docket No. T-37591, In re: Cancellation of Common Carrier Certificate No. 7507-A for failure to maintain the required insurance coverage on file with the Commission pursuant to Commission's General Order dated October 13, 2023.

ORDER OF DISMISSAL

The Louisiana Public Service Commission ("Commission") issued a citation to DTK Enterprises, LLC dba Midas Touch Towing ("Carrier") on May 23, 2025, directing the Carrier to appear at a hearing on July 10, 2025. Notice of the proceeding was published in the Commission's *Official Bulletin* on June 6, 2025. The hearing was continued several times, most recently until March 5, 2025. On November 14, 2025, Commission Staff filed a *Motion to Dismiss*, requesting to dismiss this matter with prejudice advising that all issues have been resolved.

This dismissal is prepared in accordance with Rule 56(d) of the Rules of Practice and Procedure of the Commission, which provides:

Except at the discretion of the administrative law judge, the procedures contained within subpart (a) of this Rule shall not apply to a motion to dismiss jointly filed by all parties of record, a motion to dismiss with prejudice filed by the party who instituted the proceeding, or a motion to dismiss without prejudice filed by a party who instituted the proceeding but prior to the filing of any other party's filing of a responsive pleading. Upon the filing of such a motion to dismiss, the administrative law judge may forego all recommendation procedures and prepare an appropriate order of dismissal for issuance by the Commission.

IT IS THEREFORE ORDERED:

That Docket Number T-37591 is DISMISSED with prejudice.
