Notice of Non-Compliance with Order No. S-35895

Dear Counsel:

This letter is to advise Brightspeed of Louisiana, LLC, d/b/a CenturyLink of Louisiana, LLC) ("Brightspeed") is not in compliance with The Louisiana Public Service Commission ("LPSC" or "Commission") Order No. S-35895, which requires: "Upon Commission designation as an ETC, the Company will provide Staff with a copy of the advertisement(s) for its federally supported services intended for distribution in Louisiana for Staff approval. Staff will approve or provide recommended changes to the proposed advertisement within thirty days of receipt of the same."

As of the date of this letter, Brightspeed has failed to file, or provide Staff, a sample advertisement for its federally supported services. Furthermore, this is the Commission's second request for Brightspeed to get into compliance with Order No. S-35895. Therefore, Staff directs Brightspeed to file into the record of this proceeding on or before Monday, November 18, 2024, or 30 Days from the

date of this letter a copy of its advertisement as required by Order No. S-35895. Should Brightspeed fail to comply by the date provided, Staff can seek to relinquish Brightspeed's ETC designation, as well as seek cancellation of its certificate with the Commission.
