KNOW ALL MEN BY THESE PRESENTS:


We, the undersigned, Board of Directors of Great Southern Coaches of Arkansas, Inc., a corporation duly organized and existing under Louisiana laws with principal office at 4770 Southern Ave., Shreveport, LA, hereby resolve to dissolve the corporation, effective **December 31, 2025**. This decision follows a thorough review of the corporation's financial and operational status.


At a special meeting of the Board of Directors held on December 30, 2025 with prior notice given to all directors and duly called for the purpose, at which meeting a quorum was present and acted throughout, the following resolution consistent with the Articles of Incorporation and By-Laws of the Corporation was duly approved.

“RESOLVED THAT the consent of the Board of Directors be and is hereby given for the closure of Red River Trailways, as well as Great Southern Coaches of Arkansas, Inc., with business address at 4770 Southern Ave., Shreveport, LA, effective December 31, 2025.”

Upon completion of the dissolution process, Great Southern Coaches of Arkansas, Inc., will cease all operations and its legal existence will be formally terminated. The Board confirms that all necessary steps for dissolution, including asset liquidation and creditor settlement, will be fully executed in accordance with applicable laws.
