**CONTRACT CARRIER PERMIT**

**NO. 1653-A**  
(Cancels Permit No. 1653)

**A PERMIT TO OPERATE IN LOUISIANA INTRASTATE COMMERCE AS A CONTRACT CARRIER BY MOTOR, SERVING NOT MORE THAN FIVE PARTIES UNDER THE PROVISIONS OF TITLE 45 CHAPTER 4 OF THE REVISED STATUTES OF 1950, IS HEREBY GRANTED TO KASS BROS, INC. whose office or place of business is at WESTWEGO, LOUISIANA, to operate as follows:**

Transportation of sewerage waste and discarded tires for disposal or shredding for the Jefferson Parish Department of Public Utilities, all divisions and for two unnamed Jefferson Parish political subdivisions or governmental entities.

Restricted against the transportation of non-hazardous waste via dump trucks originating in the Parishes of St. John the Baptist, St. Charles and St. James.

Restricted against the transportation in roll-on/roll-off boxes.

Restricted against the transportation in vacuum trucks.

(Re-issued pursuant to S-32038 for a name change from Kass Brothers, Inc., originally issued July 31, 1995. Except for cause beyond control, non-operation of an authority for a period of six (6) months could lead to its cancellation pursuant to La. R.S. 45:166, Paragraphs B and C.)

Said **KASS BROS, INC.** shall so operate for parties authorized under contracts, copies of which are to be filed with the Louisiana Public Service Commission, subject to rules and regulations of the Commission bearing thereon.
