A CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY IS HEREBY GRANTED TO PROGRESSIVE WASTE SOLUTIONS OF LA INC. whose office or place of business is at ALEXANDRIA, LOUISIANA authorizing operations in Louisiana intrastate commerce as a COMMON CARRIER OF SPECIAL COMMODITIES OVER IRREGULAR ROUTES by motor, handling the following described commodities, in territories described:

Transportation of institutional and household waste, garbage and refuse, trash, debris and green waste, statewide.

Transportation of sewer and municipal waste water sludge, statewide.

Transportation of any and all waste generated by municipalities in Rapides parish, only.

Transportation of any and all waste destined to Rapides Parish for recycling processing purposes.

Transportation by dump truck of non-hazardous industrial waste, restricted to points of origin and destination north of an imaginary east/west line drawn through the southernmost border of the City Limits of Alexandria, Louisiana, as well as the remainder of Rapides Parish and a one mile radius of the City Limits of Oakdale, Louisiana, and further restricted against transportation in the following Parishes: West Baton Rouge, Iberville, Ascension, Pointe Coupee and St. James.

Restricted to the use of fifteen (15) trucks and trailers in the transportation of hazardous and non-hazardous industrial waste.

Restricted against the use of roll-off dump boxes in the transportation of hazardous and non-hazardous industrial waste.

Restricted against the use of leased vehicles and/or owner-operators in the transportation of hazardous and non-hazardous industrial waste.

Restricted against transportation by vacuum trucks.

Applicant agrees not to amend certificate with regards to hazardous and non-hazardous industrial waste for a period of seven (7) years from the date of certificate, 5966-B dated March 3rd, 1994, unless written approval is obtained from C.M. Penn and Sons, Inc. its successors or assigns.
