A CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY IS HEREBY GRANTED TO UV LOGISTICS, LLC DBA UNITED VISION LOGISTICS whose office or place of business is at **LAFAYETTE, LOUISIANA** authorizing operations in Louisiana intrastate commerce as a COMMON CARRIER OF SPECIAL COMMODITIES OVER IRREGULAR ROUTES by motor, handling the following described commodities, in territories described:

Transportation of those commodities which because of their size/weight require special handling; from, to and between all points and places in the State of Louisiana.

Restricted against the transportation of commodities in vacuum trucks.

Restricted against the transportation of all liquid commodities transported in bulk quantities including but not limited to salt water, brine water, liquid mud, oil well completion fluids, chemicals, liquid industrial waste, oilfield waste, crude oil or any liquid that could be transported by vacuum trucks or trailers.

Restricted against the transportation of commodities in bulk.

Passengers on a call and demand basis over irregular routes between all points in the State of Louisiana.

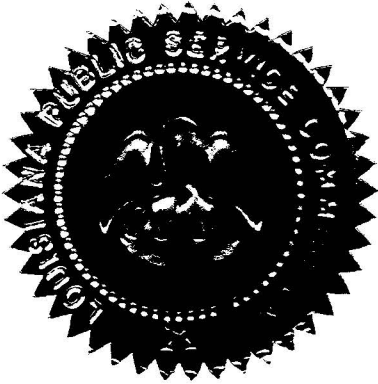
