In re: Alleged violation of 1) Louisiana Revised Statutes Title 45:1177 and General Order dated November 22, 2011 for failure to properly pay to the state fees for the years 2018, 2019, and 2020 for the inspection, control, and supervision of its business service and rates authorized in Common Carrier Certificate Number 5653-M and 2) contempt of Commission Order No. T-35152.

AFFIDAVIT AND STIPULATION

I, ERIC JONES, whose title or position is CEO of Stafford Transport of Louisiana, Inc. dba CEI ("CEI"), herein admit that CEI violated Louisiana Revised Statutes Title 45:1177 and General Order dated November 22, 2011 by (1) failing to properly pay to the state fees for the years 2018, 2019, and 2020 for the inspection, control, and supervision of its business service and rates authorized in Common Carrier Certificate Number 5653-M and (2) is in contempt of Commission Order No. T-35152. As a result, I agree to the imposition of a \$2,000.00 fine with \$1000.00 of the fine being suspended contingent on the statements below.

1. CEI will not violate La. R.S. 45:1177 or General Order dated November 22, 2011 for three years from the date of execution of this Affidavit and Stipulation.
2. Complete the following by **February 1, 2022**.
 - o CEI to provide the commission the previously suspended fine in Docket T-35152 of \$500.00;
 - o CEI to provide the Commission this executed affidavit and the stipulated fine of \$1025.00.
 - o CEI to pay the Louisiana Department of Revenue the aforementioned inspection and supervision fees for the years 2018 through 2020;
 - o CEI to provide the Commission copies of the aforementioned inspection and supervision fee reports for the years 2018 through 2020;
 - o CEI to provide the Commission copies showing proof of the aforementioned additional inspection and supervision fee payments.

3. CEI will provide the Commission proof of inspection and supervision fee report for the year of 2021 and proof of payment of inspection and supervision fees no later than **March 7, 2022;**

I understand that failure to comply with any of the above will result in the \$1000.00 suspended fine be due immediately. I further understand that failure to comply with the above may result in the institution of contempt proceedings by Commission Staff against CEI.

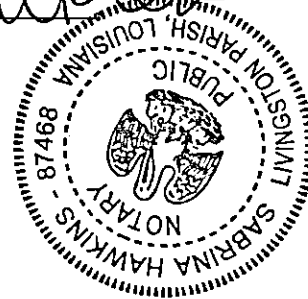


