In re: Application to convert Contract Carrier Permit number 1692 to a common carrier certificate allowing for transportation of non-hazardous oilfield waste, non-hazardous industrial solid waste and hazardous waste for disposal, statewide.

### REPORT OF INITIAL STATUS CONFERENCE

A status conference was convened in this proceeding on June 3, 2019, before Administrative Law Judge Steve Kabel. Participating in the status conference were:

The parties engaged in a discussion of the Applicant's request for authority. The parties also discussed a change in ownership of the Applicant that has occurred and that will be the subject of a separate docket. The parties then agreed to a procedural schedule.

### PLEASE TAKE NOTICE that the following procedural schedule is hereby established:

Discovery deadline (all discovery to be completed by this date).

August 8, 2019	By this date, Commission Staff shall file notice of any complaint, citation, or violation pending against the Applicant.
August 8, 2019	By this date, the Tribunal is to be advised of whether the Applicant's request for authority will proceed as a contested or an uncontested matter at hearing.
August 8, 2019	Filing deadline for Pre-Hearing Statement, including the following:
	(1) List of exhibits;
	(2) List of witnesses, and if the hearing is uncontested, whether the testimony will be presented in person at the hearing or in

writing (deposition or affidavit); and

(3) If the hearing is contested, a list of any contested issues.

August 15, 2019

Hearing. A hearing in this matter will be convened at 10:00 AM on Thursday, August 15, 2019 in the 11<sup>th</sup> Floor Hearing Room of the Galvez Building, 602 North Fifth Street, Baton Rouge, Louisiana.

All parties intending to present evidence at the hearing shall bring a copy of each exhibit for the court reporter, as well as additional copies for the judge, the research attorney, and all other parties to the proceeding. Hearing exhibits presented to the court reporter for admission into the hearing record shall be single-sided.

Any party seeking a continuance of the hearing date must file a motion for the continuance by August 8, 2019. The motion must also contain a statement (1) affirming that the moving party has contacted all other parties to the case concerning the proposed continuance and (2) advising of the position of each of the other parties to the proposed continuance. Motions for continuance filed after this date will be considered only upon a showing of good cause for the delay.

At the hearing, the applicant will have the burden of proving the applicant's fitness to receive the requested authority. See General Order (R-34054) dated January 23, 2018; the Commission's Rules of Practice and Procedure, including but not limited to, Rule 33 Applications for Authority to Transport Non-Hazardous Oilfield Waste, Hazardous Waste, and Non-Hazardous Industrial Solid Waste, and Rule 34, Evidence in Uncontested Proceedings; and La. R.S. 45:164(B).
