
Pursuant to Section 252(e) of the Telecommunications Act of 1996 (the "Act"), the Louisiana Public Service Commission ("Commission") notifies BellSouth Telecommunications dba AT&T Louisiana and DISH Wireless LLC of the following:

1. On April 21, 2021, the Commission received a Request for Approval of an Interconnection Agreement between the aforementioned parties pursuant to Sections 251 and 252 of the Telecommunications Act of 1996. The request was published in the Commission's Official Bulletin dated April 16, 2021.
2. The fifteen (15) period for intervention expired without intervention or protest being received by the Commission.
3. As noted in your request, Section 252(e) of the Act requires that the Commission approve or reject an Interconnection Agreement within ninety (90) days of its submission.
4. Pursuant to Section 252(e):
  - a. The Commission has not found that the Agreement discriminates against a telecommunications carrier not a party to the agreement.
  - b. The Commission has not found that the agreement is inconsistent with the public interest, convenience or necessity.

Accordingly, the request for approval of an Interconnection Agreement between BellSouth Telecommunications dba AT&T Louisiana and DISH Wireless LLC pursuant to Sections 251 and 252 of the Telecommunications Act of 1996 is **deemed approved**. This letter closes the docket and no further action is required.
