PETITION TO PARTICIPATE AS INTERESTED PARTY

NOW BEFORE the Louisiana Public Service Commission (“Commission”), through undersigned counsel, comes Exelon Generation Company, LLC (“ExGen”), who respectfully requests that it be allowed to participate as an interested party in the above-captioned proceeding as follows:

1.

ExGen is a subsidiary of Exelon Corporation, with its principal offices located at 10 South Dearborn Street, Chicago IL 60680. ExGen, through subsidiaries, is the largest producer of carbon-free energy in the country, owning more than 30 GW of total power generation, including generation resources within the Midcontinent Independent System Operator region that includes Louisiana. ExGen also provides wholesale electric supply to utilities, cooperatives and municipalities, including in Louisiana.

This matter was noticed in the Commission’s Bulletin No. 1241, dated March 19, 2021, with a fifteen (15) day intervention period. Therefore, this Petition is timely.

This matter involves a request by 1803 Electric Cooperative, Inc. (“1803”) for approval of
