NOW BEFORE THIS COMMISSION, through undersigned counsel, comes SOUTHWEST LOUISIANA ELECTRIC MEMBERSHIP CORPORATION ("SLEMCO"), who avers as follows:

1.

SLEMCO is an electric cooperative formed in 1937 and existing pursuant to the Louisiana Electric Cooperative Law, La. R.S. 12:401, et seq. SLEMCO serves approximately 117,000 meters in the Parishes of Acadia, Avoyelles, Cameron, Evangeline, Iberia, Lafayette, St. Landry, St. Martin, and Vermilion, with its main office located in Lafayette, Louisiana.

2.

Pursuant to the provisions of the Louisiana Constitution, Article IV, Section 21, when a public utility files a proposed rate schedule that would result in a change in rates, it is required to give notice of such application by publication in the official state journal and the official journal of each parish within the geographic area in which the rate schedule would become applicable.

3.

On December 30, 2024, SLEMCO filed an Application for Letter of Non-Opposition to Establish Regulatory Assets and Recovery of Costs ("Application") with the Louisiana Public Service Commission ("Commission") and was originally designated as LPSC Docket No. S-

37464. This docket was later converted to a U docket and was re-published in Bulletin No. 1353 on July 3, 2025.

4.

After the docket was converted to a U docket and re-published for the July 3, 2025 Bulletin, SLEMCO caused to be published in the official journals of each of the parishes described above, and in the office state journal, the notice of filing of the Application and the associated rate changes and modifications.

5.
