After review of the record, the Louisiana Public Service Commission Staff ("Staff") states that the following actions have occurred in the above-referenced docket:


- (1) The application submitted by Broadview Networks, Inc. ("Broadview" or the "Company") was filed on April 24, 2025 providing notice of a series of transactions that will result in *pro forma* changes in the indirect ownership of the Windstream Licensees and the Uniti Licensees pursuant to the approval and closure of the transaction approved in Docket No. S-37237 (the "Windstream-Uniti Transaction").

- (2) Notice of the filing was published in the Commission's Official Bulletin No. 1349 on May 9, 2025.
- (3) The fifteen (15) day intervention period in this docket expired without intervention or protest on May 26, 2025.
- (4) Staff detected no compliance issues involving the parties to the proposed transaction.

This letter is to acknowledge that Staff has reviewed the above-docketed matter. Additionally, at present there are no outstanding compliance issues involving the Company. Therefore, pursuant to Section 301(M)(1) of the Louisiana Public Service Commission's Regulations for Competition in the Local Telecommunications Market (Attachment A to General Order No. R-31839 dated March 11, 2014), this request is deemed **approved** without further action by the Louisiana Public Service Commission, and the above-docketed matter will be closed.
