**PETITION FOR LATE INTERVENTION**

**NOW BEFORE THIS COMMISSION**, through undersigned counsel, comes Entergy Louisiana, LLC ("ELL" or the "Company"), who pursuant to Rule 10 of the Louisiana Public Service Commission's ("LPSC" or the "Commission") Rules of Practice and Procedure ("Rules"), respectfully submits this Petition for Intervention with respect to the above-captioned proceeding. In support of this Petition for Intervention, ELL represents the following:

**I.**

The Company a limited liability company duly authorized and qualified to do and doing business in the State of Louisiana and is a regulated utility that was organized for the purposes, among others, of developing, manufacturing, generating, transmitting, distributing, and selling electricity for power, lighting, heating and other such uses. ELL conducts business in fifty-eight (58) of the sixty-four (64) parishes of the State of Louisiana.

**II.**

This docket stems from South Alexander I, LLC; South Alexander II, LLC; South Alexander III, LLC; South Alexander IV, LLC; South Alexander V, LLC; South Alexander VI, LLC; South Alexander VII, LLC; South Alexander VIII, LLC; South Alexander IX, LLC; South Alexander X, LLC; South Alexander XI, LLC; and South Alexander XII, LLC (collectively

"Petitioners") Petition for Reservation of Capacity on an Expedited Basis, which was filed on April 3, 2018. Notice of the request appeared in the Commission's Official Bulletin No. 1164, dated April 6, 2018, and stated that interventions must be filed within 15 days of the date of the Commission's Official Bulletin, or by April 23, 2018.

### III.

In their Petition, Petitioners are requesting that the LPSC issue an order reserving 29.5 megawatts ("MW") of capacity under ELL's Schedule REP. Thus, the Company has a substantial interest in the outcome of this proceeding. The Company's interests in this proceeding cannot be represented or protected adequately by any other parties.

### IV.

Pursuant to Rule 10 of the LPSC's Rules, "[a]ny party actually in interest may appear in any proceeding before the" LPSC.

### V.

The deadline for filing interventions has passed by only four days. The Company asks that this petition for late intervention be granted as this matter is in its initial phases.
