**SUBMISSION OF PROOFS OF PUBLICATION**

NOW BEFORE the Louisiana Public Service Commission (“**Commission**” or “**LPSC**”), through undersigned counsel, comes Panola-Harrison Electric Cooperative, Inc. (“**PHEC**” or the “**Cooperative**”), who avers as follows:

1.

PHEC, a Louisiana and Texas electric cooperative, provides electric services in Caddo and DeSoto parishes in Louisiana.

2.

On May 15, 2024, PHEC filed an Application of Panola-Harrison Electric Cooperative, Inc. for Approval of Modifications to Base Rate Charges and Modifications to Standard Terms and Conditions (“**Application**”) with the Commission. The Application requests, *inter alia*, a revenue increase and proposes revisions to PHEC’s rate schedules, rate riders, and standard terms and conditions, which could result in an increase in rates.

Pursuant to the provisions of the Louisiana Constitution, Article IV, Section 21, when a public utility files a proposed rate schedule that would result in a change in rates, it is required to

give notice of such application by publication in the official state journal and in the official journal of each parish within the geographic area in which the schedule would become applicable.

Accordingly, after the filing of the Application, PHEC caused to be published in the official journals of each of the parishes described above and in the official state journal the notice of filing of the Application.
