On behalf of Cleco Power LLC ("Cleco Power" or the "Company"), we are requesting the authorization of the Louisiana Public Service Commission (the "Commission") to extend the filing date of Cleco Power's 2023 rate case from March 31, 2023, to June 30, 2023. Pursuant to Commission Order No. U-35299, issued June 22, 2021, Cleco Power is required to submit its next rate case filing by March 31, 2023,<sup>1</sup> for rates to be effective July 1, 2024. Cleco Power is requesting the extension of the March 31, 2023, filing date in order to conduct further analyses that will help Cleco Power appropriately balance the needs of the Company's customers for reliable power at a reasonable price with the continued financial stability of the Company.
