In re: Proposed amendments to Commission General Orders dated April 21, 1999, November 08, 1999, April 25, 2012, and March 16, 2021 and supersede General Order dated May 30, 2008 and October 13, 2023, as well as establishment of rules for transporters of waste and saltwater to coincide with recent amendments to intrastate motor carrier insurance requirements.
