A CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY IS HEREBY GRANTED TO <u>C&J WELL SERVICES</u>, <u>INC. DBA C&J ENERGY SERVICES</u> whose office or place of business is at <u>HOUSTON</u>, <u>TEXAS</u> authorizing operations in Louisiana intrastate commerce as a COMMON CARRIER OF **WASTE** OVER IRREGULAR ROUTES by motor vehicle.

Transportation of non-hazardous oilfield waste, statewide, with the following restrictions:

- 1. Restricted to the transportation of waste which originates in the following Parishes: Vernon, Rapides, Avoyelles, Concordia, Catahoula, La Salle, Grant, Natchitoches, Sabine, De Soto, Red River, Bienville, Jackson, Winn, Caldwell, Franklin, Tensas, Madison, Richland, Ouachita, Lincoln, Caddo, Bossier, Webster, Claiborne, Union, Morehouse, West Carroll, East Carroll, Lafayette, Iberia, and St. Martin.
- 2. Restricted against the transportation in roll-off and end dump trucks.
- 3. Restricted to the use of no more than twelve (12) trucks in the parishes of Lafayette, Iberia, and St. Martin.
- 4. *C&J Well Services, Inc.* shall not apply for any new or authority for non-hazardous oilfield waste, non-hazardous industrial solid waste, and hazardous waste in the State of Louisiana for a period of two (2) years from the date of this Certificate.

(Issued pursuant to Order No. T-33991 dated June 10, 2016. Except for cause beyond control, non-operation of an authority for a period of six (6) months could lead to its cancellation pursuant to La. R.S. 45:166, Paragraphs B and C.)

Said <u>C&J WELL SERVICES</u>, <u>INC. DBA C&J ENERGY SERVICES</u> shall perform such operations under tariffs now or hereafter filed with the Commission and in compliance with all laws and rules and regulations of the Commission bearing thereon.
